These failures and violations provide a sufficient basis to issue a Notice of Intent to Revoke the Charter Holder’s contract.</i></p> <p><i>However, the Board is authorized to exercise its legal discretion with regard to actions taken against a charter holder that is not in compliance with its charter, other obligations to the Board, and state and federal law. In an effort to bring the Charter Holder into compliance, the Board directs staff to work with legal counsel to develop a consent agreement that addresses the Charter Holder’s noncompliance with the Board’s operational performance expectations, its charter, and state and federal law. The Board further directs staff to bring the consent agreement back to the Board for consideration at a subsequent board meeting.
