AMENDMENT REQUESTS

A change to a charter requires the consent of both the Board and charter holder. To obtain the Board's consent for a change to a charter, a charter holder shall submit a charter amendment request to the Board. R7-5-303(A).

The calendar below includes specific timeframes for the submission of expansion amendment requests. These submission timeframes provide the Board appropriate time to consider expansion requests prior to the beginning of the school year in which those changes will be implemented. There are certain requests that do not need to go to the full Board for approval. Amendment Instructions and requirements are available on the Board's website.

DEADLINES

- Expansion amendment requests to be implemented in FY 2023 may be submitted until March 14, 2024, for approval by the Board no later than the May 13, 2024 meeting. The Executive Director has the discretion to waive this deadline due to emergency or extreme circumstances.
- Beginning March 15, 2024, expansion amendment requests for FY 2027 may be submitted for consideration starting in August 2024.
