

Checklist: Level Two "On Probation" Charter (FY2023 Audit)

Use this checklist if your charter has been identified as **"On Probation"** under Arizona Administrative Code (A.A.C.) R7-5-402(G) based on the FY2023 audit <u>and</u> assigned to **Probation Risk Level Two** under A.A.C. R7-5-402(J). This checklist IS NOT applicable to charters assigned "Good Standing" or "Adequate Standing" summative financial performance ratings. "On Probation" charters assigned to Probation Risk Level One or Three or charters assigned their first "Intervention" rating based on the FY2023 audit should use the corresponding checklist.

ATTESTATION

In addition to the quarterly submissions specified in this checklist, a Probation Risk Level Two charter holder must provide to the Board the attestation required under A.A.C. R7-5-402(J)(1).
