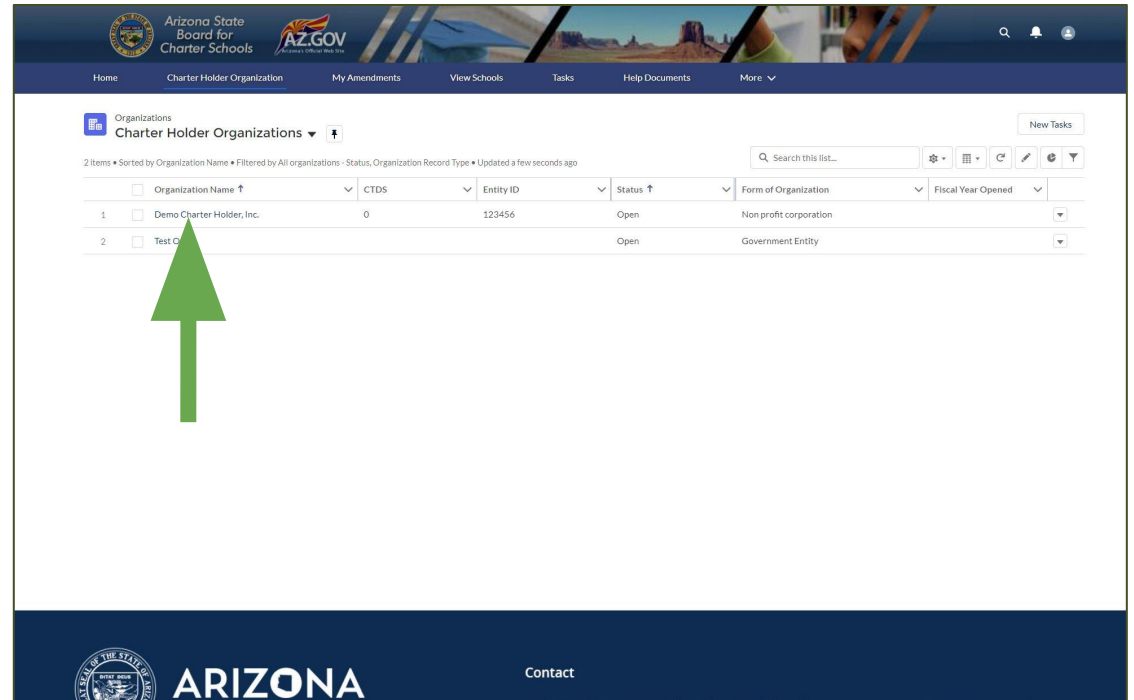
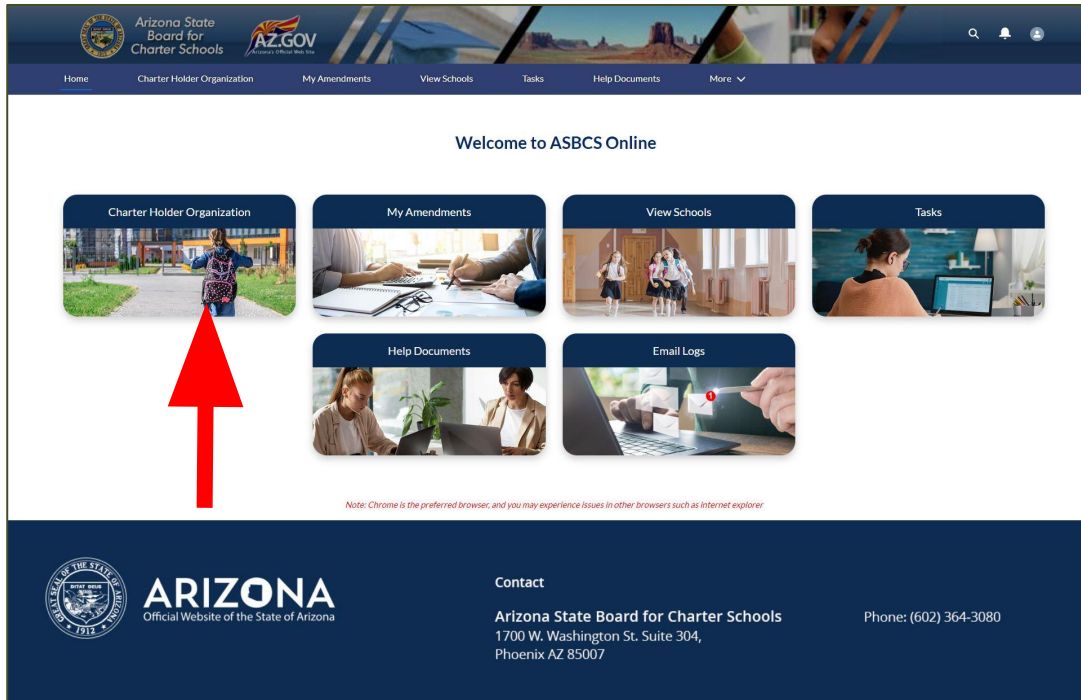

Annual Education Service Provider Declaration

Arizona Administrative Code ("A.A.C.") R7-5-501(D) states, "By September 1 of each year, each charter holder must notify the Board, whether they have an agreement or contract with an education service provider for the current school year. If the charter holder has an agreement or contract with an education service provider, then the charter holder must provide:

1. The name of the education service provider; and
2. A statement describing the services provided to the charter holder's charter school(s) by the education service provider.

According to A.A.C. R7-5-101 an "education service provider" means an organization that contracts with or has a governance relationship with an applicant or charter holder to provide academic services, administrative services or both. These organizations may also be commonly referred to as charter management organizations or education management organizations.

Failure to accurately and timely report the information required by A.A.C. R7-5-101(D) may be identified as a noncompliance issue and may be recorded in Measure 2e of the charter holder's operational performance dashboard.
