Arizona Online Instruction (AOI) School and Program Amendment

Eligibility:

Any charter holder sponsored by the State Board of Education or the State Board for Charter Schools that is currently in compliance and not under a corrective action plan may submit an AOI Amendment to be an AOI School or Program under A.R.S. §15-808 for grade levels currently approved as part of the charter. Staff utilizes the Board's Policy on Conducting Compliance Checks of Charter Schools for determination of compliance. (http://asbcs.az.gov/userfiles/Compliance%20Check%20Policy.pdf).

Charter holders are encouraged to conduct their own compliance review to ensure eligibility prior to submitting an Amendment Request.

Submission Timeframes:

There will be two initial amendment submission deadline dates; July 1, 2010 and August 1, 2010. Upon completion of evaluation, amendments meeting the scoring criteria will be considered by the Board at the next regularly scheduled meeting. After Summer 2010, Charter Schools may submit amendments 'at will' and on a continuous basis.

Summer 2010 Schedule:

Sept 13, 2010 Amendments meeting scoring criteria considered by the Board for final approval.

Option E

Aug 1, 2010 Amendments due to Arizona State Board of Charter Schools
Oct 12, 2010 Amendments meeting scoring criteria considered by the Board for final approval.

Arizona Administrative Code R7-5-401 requires that all amendments and notifications be processed within sixty business days.

The Board or its designee will work diligently to process the amendments in a timely manner and in the order received.

Fees:

In accordance with A.R.S. § 15-183.XX, a non-refundable processing fee in the amount of \$XXXX in the form of a check or money order must be included with the submission of the AOI School and Program Amendment Request.

Evaluation Process:

The Board or its designee will:

Step One:

Determine whether the submitted materials are administratively complete and whether the charter holder is eligible to amend its charter. Administratively incomplete submissions and charter holders deemed ineligible will not continue in the evaluation process. Charter holders are encouraged to confirm all required amendment materials identified on the AOI Program of Instruction Amendment Request Form are included with the submission and confirm

compliance in all program areas identified in the Board's Policy on Conducting Compliance Checks of Charter Schools prior to the submission of the Amendment Request to avoid the forfeiture of the processing fee.

Step Two: Conduct a substantive review of the submitted materials will be completed.

The review and scoring of each amendment will be based on criteria that support sustained and intensive high-quality online learning. Using a qualitative and quantitative scoring system, this process is intended to identify the applications that meet the needs of Arizona's eligible online instructional school and program requirements.

An expert panel will evaluate eligible applications according to or against the required application components and the established criteria reflected in the scoring rubric. The review panel will review each eligible application and make recommendations for acceptance. Following the review, the Charter Board or designee will contact Charter Holders to discuss any modifications that may be required. Applicants may be asked to revise the proposal. Step Three: Evaluate the charter holder's ability to implement the described program will be conducted if

the materials meet the scoring criteria during the substantive review.

Step Four: Create the summary of the evaluation and demonstration for the Board's consideration.

Board Consideration:

Submissions that meet the scoring criteria and successfully demonstrate the ability to implement the AOI program or school under A.R.S. §15-808 will be placed on the Consent Agenda of the Board's next regular meeting. Submissions that do not meet the scoring criteria or do not successfully demonstrate the ability to implement the AOI program or school under A.R.S. §15-808 will be notified. Upon notification, the Charter Holder may request to be placed on the Board's next regular meeting agenda.

Amendment Materials:

Narrative sections must be type written, double-spaced and the font used must not be smaller than 12 point. Arial, Courier, or Calibri are permitted font types. There must be one inch side, top, and bottom margins. Please limit narrative to 35 pages. Any supporting charts, graphs, and tables must be placed in the Appendix and referenced in the narrative.
