

## **Academic Intervention Premise**

- Academic Interventions impact only Charter Holders that operate schools that do not meet the Board's academic performance standards.
- The Board's Academic Interventions focus on five areas: Data, Curriculum, Assessment, Monitoring Instruction, and Professional Development, which are essential elements for improving a school's academic performance.
- A Charter Holder assigned a PMP must create a detailed and comprehensive improvement plan that incorporates each of these elements.
- A Charter Holder assigned a DSP must provide evidence that they have implemented a successful improvement plan that incorporates each of the required elements.
- The PMP and DSP processes are based around guiding questions that focus Charter Holders on these essential elements when creating an improvement plan and reporting on the implementation and success of that plan.

# Policy Consideration – Renewal Application Requirements

- **Current Requirements:** Charter Holders operating schools that have received an overall rating of "Does Not Meet Standard," "Falls Far Below Standard," or "No Rating" on the Academic Performance Framework in *either* of the two previous years are required to complete the Academic Performance Section of the renewal application, including a DSP with site visit.
- Recent Renewal Decisions: All Charters Holders that received an overall rating of "Does Not Meet Standard," "Falls Far Below Standard," or "No Rating" on the Academic Performance Framework in the previous year, but an overall rating of "Meets Standard" in the most recent year were granted renewal contracts whether or not they successfully demonstrated sufficient progress through the DSP process, because of the Board's ability to continue monitoring their academic performance.
- **Recommendation**: Require only Charter Holders who have received an overall rating of "Does Not Meet Standard," "Falls Far Below Standard," or "No Rating" in the most recent year to complete the Academic Performance Section of the renewal application.

Meets to Meets	Met the Board's academic standards in FY 12 and FY13 and was not required to submit a DSP.	May submit anytime prior to the next dashboard
DNM to Meets	3 of 4 schools provided DSPs that were evaluated as "Not Acceptable" and their overall rating decreased.  1 of 4 schools provided a DSP that was evaluated as "Acceptable" and maintained a Meets.	May submit between January - March with DSP
Meets to DNM	1 school provided a DSP that was evaluated as "Not Acceptable" and maintained a Does Not Meet.	May not submit until next dashboard with a Meets
DNM to DNM	3 schools provided DSPs that were evaluated as "Not Acceptable" and maintained a Does Not Meet or FFB.	May not submit until next dashboard with a Meets
