

**Adding Grade Levels to Charter Amendment Request:
Academy Del Sol, Inc.**

1. Narrative:

a) *Background and Support for Expansion*

When Academy Del Sol, Inc. originally submitted and had its charter approved in January of 2009, it was their intention of serving grades K-6 for year one and then implementing 7th grade beginning year two, August 2010 and 8th Grade in year three, August 2011. As a result, mention of these plans were included in the original charter. The owners of Academy Del Sol would like to proceed with the original plan proposed in 2009.

At present, Academy Del Sol serves students in 7th grade who are anticipating continuing their education at Academy Del Sol and this can only be done with the addition of 8th grade.

Additionally, in its first year of operation, Academy Del Sol received four students mid-year from traditional middle schools that serve grades 6-8. In year two, Academy Del Sol added 5 middle school students mid-year. As a result, it has been concluded that an Academy Del Sol education is in demand when compared to other school choices at the middle school level.

b) *How Additional Grades Support Philosophy, Methods of Instruction, Special Emphasis, and Charter Mission*

Additional grades support the philosophy, methods of instruction, special emphasis, and charter mission in the following ways:

Philosophy Supported:

Philosophy:

While there are several definitions, aims and purposes of education, the founders of Academy Del Sol have ideas that are ever changing and constantly developing. Our founders believe that all students, regardless of socio-economic status, race, or ethnicity, have the right to receive a superior quality education. Currently, Academy del Sol's philosophy is comprised components from the *perennialism, essentialist, and progressivism philosophies.*

The addition of 8th grade supports this philosophy by allowing Academy Del Sol to continue in its development of their philosophy. Additionally, it allows for a greater number of students to be served regardless of socio-economic status, race, or ethnicity. It opens up a superior quality education to all students, including those at the middle school levels. This education will teach students *how* to think, provide them with knowledge so they can live productive lives today, and allow them to learn by doing.

Implementing grades 7th and 8th grade support the methods of instruction, however, more importantly, the methods of instruction support students in 7th and 8th grades. The methods are varied, and include both teacher and student centered methods. As a result, providing mixed methods of instruction will provide for the motivational needs students, as motivation is often a factor with students in these grade levels. As a result, students will be more likely to continue their education to the high school level.

Special Emphasis Supported:

There are three foci at ADS.

- 1: academics (reading, writing, math, science)
- 2: fine arts (art-disciplined based art education, drama, dance, music)
- 3: practical life

At the elementary level, reading is already emphasized with a daily 45-minute enrichment beyond the 90-minute core reading block. Writing is emphasized with a 60 minute block, and with the instruction of the 6-traits of writing and the writing process. Math is emphasized with daily intervention time embedded within the 60 minute math core. Fine arts is emphasized with the requirement that all students and classes to perform or produce displays throughout the year during various school wide and community events. Practical life is emphasized with in-class and school-wide activities that include but are not limited to: care of self, grace and courtesy, control of movement, care for the environment, basic nutrition and food preparation, budgeting, shopping, interviewing, greeting and introducing people, personal time management, and order (organization).

Adding additional grades would support these foci already in place by allowing middle schoolers to select "electives" for fine arts and practical life content areas. However, the special emphasis continues to be supported in the areas of reading and other academics as well because these content areas will take the place of electives should reading, writing, and math need to be further developed.

Charter Mission Supported:

Academy Del Sol's mission is to provide all students, regardless of socioeconomic status, race, or ethnicity; with a superior quality education that will instill students with the "essentials" of academic knowledge that will have infinite importance to people everywhere. This education is

not only limited to nurturing a student's intellect in teaching them *how* to think, but it also nurtures their body and spirit while allowing students to "learn by doing."

With the addition of 7th and 8th grade, Academy Del Sol is able to serve a greater quantity of students with this mission and extend the mission to older students who will have already gone through the Academy Del Sol system and would like to continue.

2. Timeline of Implementation:

Academy Del Sol plans to implement 8th grade at the beginning of their third school year to begin in August, 2011.

3. Proficiency Level Required for Credits and/or Promotion AND Credit Transfer Policies

Mastery Levels

READING:

Students will be able to orally read and comprehend text at grade level or above grade level for any given year. Categories of reading such as phonemic awareness, phonics, and fluency, will be demonstrated with the administration of the DIBELS assessment and mostly at the elementary level. As a result, this assessment will only be utilized in extreme situations where middle schoolers are not demonstrating skill in these three areas. Comprehension and reading skills and vocabulary will be assessed using a school wide quarterly written assessment in which students will score a 75% or above on these summative assessments.

WRITING:

Students will score an average of 3.7 or higher on their quarterly writing prompts based on the 6-traits of writing. (See table below)

4.7-6.0: Exceeds

3.7-4.6: Meets

2.7-3.6: Approaches

1.0-2.6: Falls Far Below

MATH:

Students will score a 75% or above on in-class summative assessments and quarterly benchmark assessments.

Mastery Levels for Promotion and Retention

A.D.S will use the 1, 2, 3, 4 grading scale. The scale is as follow:

4-Exceeds the standard	95-100%
3-Meets the standard	75-94%
2-Approaches the standard	60-74%
1-Falls far below the standard	59% and below

A.D.S will implement standards based grading, based on *each* of the strands indicated in the AZ State Standards. For example, there are four strands of reading. Thus, there will be four different grades in the area of reading.

A promotion recommendation shall be made to all students demonstrating *proficiency* in two of the three content areas (reading, writing, and math) as indicated by district quarterly assessments, grades, and overall academic achievement. Exceptions will be made on a review basis by the school board in conjunction with support personnel, administration, teachers, and parents.

A.D.S will identify by means of academic indicators, students who may be retained. These indicators include, but are not limited to district quarterly assessments, grades, previous overall demonstrated academic achievement, social factors, attendance, teacher and/or parent recommendation. However, a student's social, physical, and emotional growth shall also be taken into consideration before retention is recommended.

Credit will be transferred for courses "passed" with requirements indicated above for reading, writing, and math.
