#### Call to order of the Academy of Math and Science Camelback Governing Board

Meeting was called to order at 10:10am by Steve Garbade.

#### Agenda 2 Consideration to approve the Accounting Policy for AMSC

A summary was sent to the board ahead of time to review. This policy is the same as the ones being used at the other campuses. Mr. Chayka mentioned that occasionally changes are made to the policy, but as of this year none have been made. This policy was used during the last financial audit as well. Mr. Hykes clarified that one of the documents provided gives the schools exemption from USFRCS (Uniform System of Financial Records for Arizona Charter Schools). The schools still follow the categories but are not beholden to them.

Steve Garbade made a motion to approve the Accounting Policy for AMSC. Lee Evans seconded. Motion passed unanimously.

#### Agenda 2 Consideration to approve the Procurement Policy for AMSC

This is the same policy as the other schools as well. Mr. Hykes asked if there were any questions. Board members were familiar of the policy from adopting in AMSS and had no questions.

#### Steve Garbade made a motion to approve the Procurement Policy for AMSC. Kim Chayka seconded. Motion passed unanimously.

### <u>Updates</u>

Mr. Chayka provided all updates. The schools are currently finalizing budgets for next year and offers for teachers. Additionally, they are interviewing/offering to new teachers. Once contracts are back there will be more to discuss at the next meetings. AzMERIT testing was just finished last week at all the AMS schools. They chose to do paper/pen tests again this year. Some schools who chose to utilize the electronic method had some issues. Both Phoenix and Tucson schools still have benchmark left at the end of the year.

Mr. Garbade asked if there would still be a meeting 4/12/16, but Mr. Chayka said it will probably be cancelled since it's so close to this meeting and updates are still pending. 5/10/16 is the next most likely meeting date.

Mr. Chayka also mentioned a new IT Director was hired: Daniel Crooks. At the time they originally heard about him working with the Phoenix schools in the chess club, the schools had no openings. Once a position opened up, they made him an offer. Mr. Crooks is located in Phoenix and is working on several certifications. In Tucson, there is tech teacher (Enlin Xu) stepping in to help out with local hardware issues. The schools also still have a contract with Integrilogic for further network issues. Lee Samdahl is confident Mr. Crook will be able to fulfill the duties as the IT Director. Mr. Garbade would like to meet with Mr. Crook and discuss the contract with Integrilogic and other projects in a few weeks. Per Mr. Chayka, next year the enrollment for Phoenix plans to grow from 1600 to 2200 students and the technology will need to keep pace with that. They are also looking at property to open the new school in Phoenix in August 2017.
