

**AGENDA ITEM EXECUTIVE SUMMARY: Charter Holder Status—Change in Legal Status Amendment Request**

**Request**

Ahwatukee Foothills Prep Early College High School, Inc. (“Charter Holder”) submitted a request to change the legal status of Ahwatukee Foothills Prep Early College High School, Inc., a Non-Profit corporation to Arizona Education Solutions, a newly formed nonprofit corporation. The provided documents include the Articles of Incorporation and Bylaws.

**Profile**

The Charter Holder was granted a new charter in 2010.

The Charter Holder is requesting to change the non-profit corporation, Ahwatukee Foothills Prep Early College High School, Inc., to the newly formed non-profit corporation, Arizona Education Solutions. Arizona Education Solutions filed as a new non-profit entity on May 9, 2018 with the Arizona Corporation Commission. The Articles of Incorporation indicate that the current board members of the non-profit corporation will remain as the board members of the newly formed non-profit corporation, and the narrative states that the corporate and governing boards will continue to be one and the same.

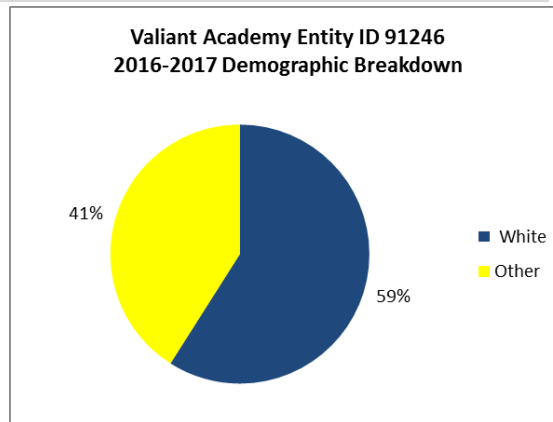
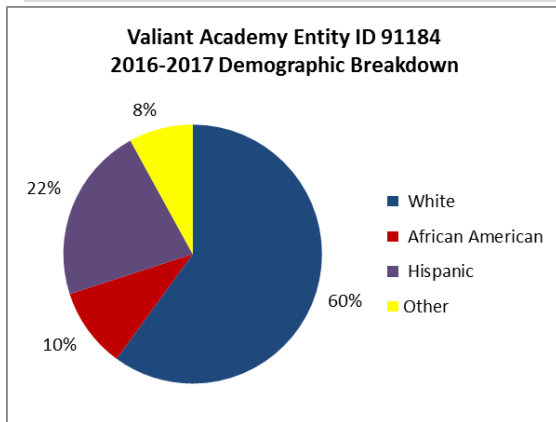
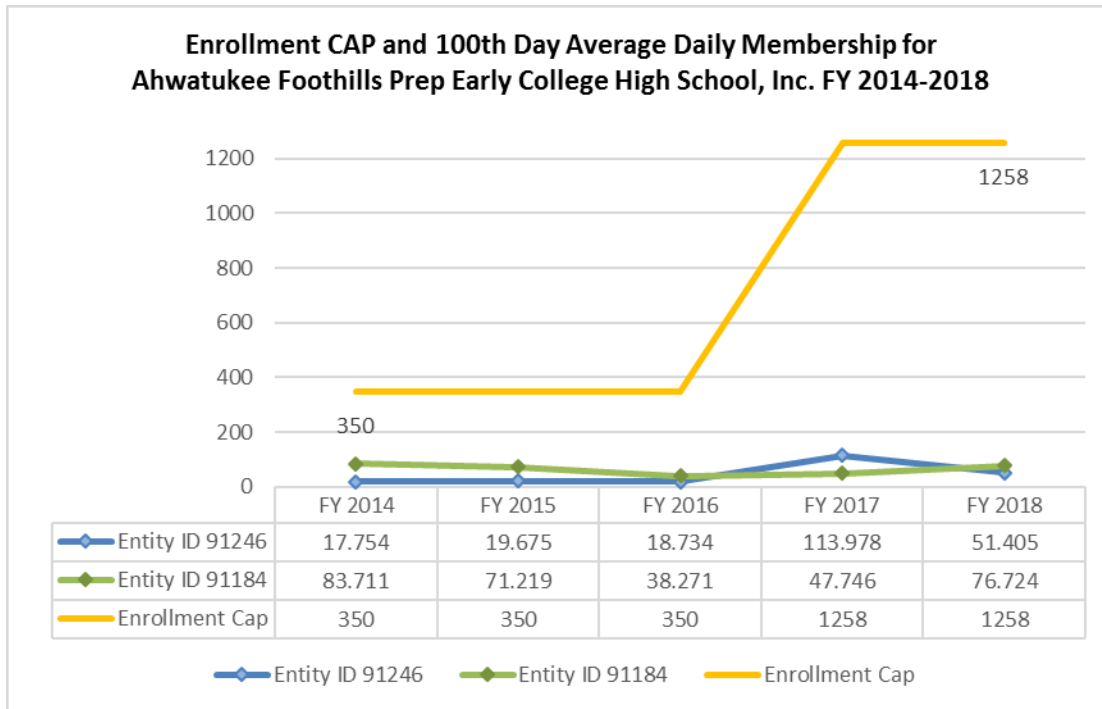
