Vista Grove Academy Public Charter Elementary School shall not purchase any goods or services from any member of the governing body, an immediate family member of any member of the governing body nor from any entity in which any member of the governing body or an immediate family member of a governing body member may benefit from such a procurement, unless authorized by the governing body after a full disclosure of the potential benefits, and after the consideration set forth in paragraph 1 above.

Vista Grove Academy Public Charter Elementary School understand that the policy cited above applies to purchases made using non-federal funds. As a condition of the receipt of certain federal funds, federal procurement requirements still apply.
