The Charter Holder meets the Board’s Financial Performance Expectations.

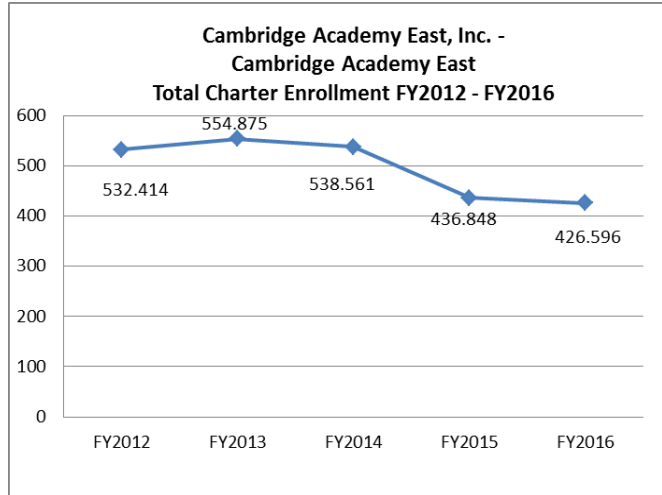

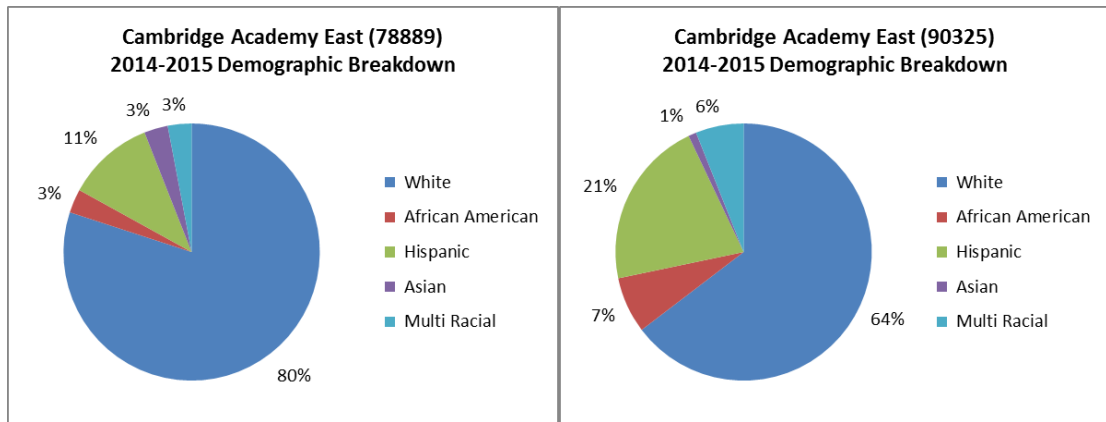
