2009-2010 Transfer Application Summary Report

Daisy Education Corporation filed a transfer application to transfer a current site, Paragon Science Academy Elementary School, operating under the State Board of Education, to its own charter contract with the Arizona State Board for Charter Schools. Daisy Education Corporation is a non-profit corporation that was incorporated on 10/19/1999. Daisy Education Corporation currently operates two school sites; Sonoran Science Academy – Tucson (K-12) and Paragon Science Academy Elementary School (K-5). The same corporate principals also hold a charter for Daisy Education Corporation dba Sonoran Science Academy – Phoenix (approved for K-12, currently operating K-10). With the transfer of the site to its own contract, the name of the school will change to Sonoran Science Academy – Ahwatukee to support its new location.

According to the Arizona Department of Education's ADMS Report 45-1, Paragon Science Academy Elementary School presently has an ADM of 149.82 students and opened on 8/11/08.

Curricular Emphasis:
