AGENDA ITEM EXECUTIVE SUMMARY: Grade Level Change to Charter Amendment Request

Request

Khalsa Montessori Elementary Schools ("Charter Holder") submitted an expansion request to increase the grade levels the Charter Holder is approved to serve, from grades K-6 to grades K-8, beginning in FY 2020. This expansion request accounts for three years of projected student enrollment.

According to the Charter Holder "due to a robust wait list, a growing interest in the school's Montessori program, and high retention of current students", it is requesting to add 7th and 8th grade. The school has been preparing for this transition since FY 2018, when enrollment in the Upper Elementary increased from 36 to 44 students. To help meet the proposed enrollment targets, the school has established annual events for prospective families to become familiar with the program, weekly school tours, and annual Montessori Silent Journey and Discovery presentations. For FY 2020, the school has committed to send the schools tenured Upper Elementary teacher to Montessori Secondary I (Middle School Training) to support implementation of the expansion. Additionally, the school has recruited a front-office secretary to maintain administrative operations for the middle school site, in addition to a part-time administrator that will oversee operations. Promotion criteria from 7th to 8th grade includes demonstration of appropriate readiness with 90% proficiency in academic work and 80% proficiency in social and emotional maturity.




