>> is very specific information in this letter that states you have 48
>> hours from the receipt of this letter to provide proof to this office

>> received by the Arizona Department of Public Safety. This requirement
>> is in addition to a copy of the completed application form being sent
>> to us also.

>> At this time, Danielle needs to obtain the appropriate identity
>> verified fingerprint package, send a copy of this completed form to
>> our office, and a copy of the tracking ticket for sending the
>> package, as well as the receipt that DPS has received the appropriate
