The Odyssey Preparatory Academy, Inc. submitted an application for a new charter school on August 1, 2008.

- The Odyssey Preparatory Academy, Inc. is a 501(c)(3) not-for-profit corporation that was created on April 11, 2008, with the purpose of conducting public education.
- The name of the school is The Odyssey Preparatory Academy and will be located in Buckeye, Arizona.
- The applicant will initially serve grades K-5 and have an enrollment capacity of 300 students in the first year and grow to 450 students by year three serving grades K-7.
- The applicant met all the substantive eligibility criteria as documented in the following pages and in the <u>attached scoring rubric</u>.
- Fingerprint clearance cards and background information for all appropriate parties were provided and reviewed. Additional information has been provided.

Applicant's Background Information:

- 1. The corporation has three members, with all three serving on the governing board:
 - <u>Megan Olson</u>: Currently teaches 8th grade math at Buckeye Middle School in Buckeye Elementary School District. Ms. Olson has an A.A. degree from Eastern Arizona College and a Bachelor of Arts in History-Secondary Education from Montana State University. She is currently pursuing a M.Ed. in Administration and Supervision from the University of Phoenix. Pursuant to the background check, the applicant stated on the employment history that she was a manager with Rainbow Motel. Owner Rochelle Gibson verified that applicant was the desk clerk. Subsequent to a staff request that the applicant explain the discrepancy, the owner of the Rainbow Motel submitted an email changing her previous verification and stating that Megan Olson was the manager from 10/01 to 7/03. Ms. Olson's credit report indicated no concerns. The education verification was validated with no concerns.
 - <u>Mary Alvarez</u>: Currently teaches an 8th grade self-contained classroom at Buckeye Middle School in Buckeye Elementary School District. Ms. Alvarez has a Bachelor of Science in Elementary Education for the University of Montana. Fingerprint clearance card and background information were provided and verified.
 - <u>Frank Yanez</u>: Mr. Yanez is president of F.M.Y. Consultants, LLC, a consulting company he started in 2004, which provides financial management advice as well as full bookkeeping services to charter schools. He is also managing partner and a founder of Sun Valley Education Business Advisors, LLC, which is a provider of financial services. Mr. Yanez is a graduate of Buckeye Union High School and attended Glendale Community College, Estrella Mountain Community College, and the University of Phoenix. Fingerprint clearance card and background information were provided and verified.

New Charter Application Background:

Comprehensive Program of Instruction/Curriculum

Short description:

Odyssey Preparatory Academy will implement the Core Knowledge® curriculum. The Core Knowledge® curriculum sequences specific topics for language arts, American and world history, geography, visual arts, music, math and science. The school plans to also implement The Singapore Math program. Both programs are intended to provide a rigorous curriculum that is both culturally rich and aimed at closing what the applicants describe as a wide achievement gap between students currently enrolled in surrounding schools and state performance objectives.

The application meets the minimum requirements in all the areas of the comprehensive Program of Instruction.

Business Plan/Budget

Short description:

The applicant has signed a letter of intent with US Charter Development to finance and construct the Odyssey Preparatory Academy facility. US Charter Development provided a letter of commitment to the applicant for such construction and financing, including a \$75,000 start up budget, through 20-year lease. Lease payments will commence pending occupancy. As stated in the letter, the applicant retains the option to purchase the facility after year 1, but before year 4.

The operational budget is based on 100% of the 300 student enrollment projected for FY09. The application does allow for adjusting expenditures should enrollment projections not be met.

The application meets the minimum requirements in all the areas of the Detailed Business Plan.

Motion Notes for Odyssey Preparatory Academy, Inc.:

- The application includes all required curriculum samples to operate a K-5 program.
- The application meets the scoring criteria in both the Program of Instruction section and Business Plan areas.
