# AGENDA ITEM: Verde Secondary Academy Public Charter High School Application Overview

Verde Secondary Academy Public Charter High School submitted an application for a new charter school on July 29, 2008.

- Verde Secondary Academy Public Charter High School is a 501c3 not-for-profit corporation that was created on July 28, 2008 with the purpose of conducting public education. The charter operations would be managed by the Leona Group, Inc.
- The name of the school is Verde Secondary Academy and will be located in Tucson, Arizona.
- The applicant will initially serve grades 9-12 and have an enrollment cap of 300 in the first year and grow to 500 by year three while serving the same grade levels.
- The applicant has MET all the substantive eligibility criteria as documented in the following pages and in the <u>attached scoring rubric</u>.
- Fingerprint clearance cards and background information including credit, employment and education have been verified for all corporate principals.

  - <u>Dr. William Coats</u>: Founder and CEO of the Leona Group, Dr. Coats currently serves as Sole Incorporator, Director and President of Verde Secondary Public Charter High School. Dr. Coats oversees 72 charter schools across six states. Dr. Coats is a former superintendent and earned his doctorate in Research and Data Analysis.
  - <u>Michele Kaye</u>: Currently serves as the Chief Operating Officer for the Leona Group since 2004. She has served in a variety of roles with the Leona Group and within the charter school arena for the past 10 years. Ms. Kaye holds a Master's Degree in Educational Leadership from Northern Arizona University.

### **New Charter Application Background:**

### Comprehensive Program of Instruction/Curriculum

Short description:

Verde Secondary Academy will implement its program of instruction based on the body of research on effective schools which established seven-correlates to produce high student achievement.

Verde Secondary Academy staff believe that all children can learn but at different rates. Verde Secondary Academy program of instruction will have as its core high yield strategies which will result in significant improvement in student achievement. These high yield strategies include:

- Standards-based course alignment
- Curriculum mapping
- Assessment of the pre and post test nature in conjunction with regularly occurring formative testing
- Cooperative learn and differentiated instruction to guarantee 100% participation
- Technology integration
- System-wide benchmark testing

Instructional staff will be trained to implement nine instructional elements as defined by J. Pollock. These nine elements incorporate the required articulated curriculum standards, planning and pacing and delivery of instruction, varying assessments and criterion-based feedback.

The application meets the minimum requirements for all areas of the Program of Instruction.

# Business Plan/Budget

Short description:

The applicant has designated \$600,000 for start-up purposes. Nearly 30% of the expenses associated with the start-up are designated for instructional supplies and training for instructors.

The operational budget is based on 100% of the projected enrollment. The application has a sufficient amount of budget balance should it be required. No categorical or grant revenues have been included in the operating budget.

The business section meets the minimum scoring requirements for all the areas within the Business Plan.

### **Motion Notes for Verde Academy Public Charter High School:**

- The application includes all required curriculum samples to operate a grade 9-12 program on an alternative schedule.
- The application met the scoring criteria in both the Program of Instruction and Business sections.
