Rationale for the decrease in grade levels served and effective date of change:

During the 2009-2010 school year we did not have any sixth grade students enrolled or receive requests for enrollment for the sixth grade. We currently do not have any, "intent to enrolls", for the sixth grade for the 2010-2011 school year.
