AGENDA ITEM EXECUTIVE SUMMARY: New School with Enrollment Cap Amendment Request

Request

Math and Science Success Academy, Inc. ("Charter Holder") submitted an expansion amendment request to add a new school to the existing charter contract and an expansion request to increase the enrollment cap from 700 to 2550, beginning in FY 2020. This expansion request accounts for 3 years of projected student enrollment.

The Charter Holder has requested to add a new school to the charter contract in order to continue to deliver "high performance in low-income and underperforming areas" and meet "the high demand exhibited" for its programs. The narrative states that the two campuses currently operated in the Phoenix area under different charter contracts (see "Schools Associated with Math and Science Success Academy" on page 3) have a "combined waiting list of approximately 2,000 students, demonstrating the demand" for its program in the area. The staffing plan includes utilizing internal candidates as administration at the new campus, and hiring 59 total staff members in the first year. According to the Charter Holder, the proposed location has a "below state average charter school saturation" and schools in the area have an average AzMERIT passing rate of 29% in ELA and 33% in Math, which is below both the state average and the performance of the existing school under the charter contract. At the proposed school, the Charter Holder intends to offer a 200-day calendar, partnerships with parents, "significantly more instructional time" than surrounding schools, and instruction in "habits of mind, study skills, philosophy, and ethics to prime students for high levels of achievement".




