

Renewal Executive Summary

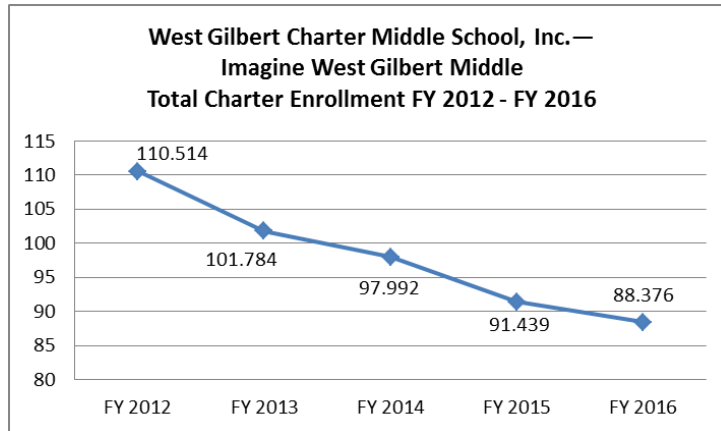
I. Performance Summary

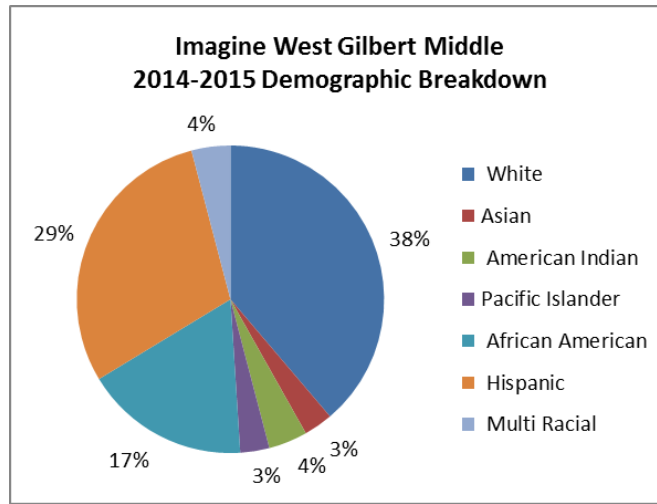
