#### Narrative for Seneca Preparatory Academy Instructional Day Amendment Request

Seneca Preparatory Academy was set to start school operations on August 6, 2015 at 601 E. E. Fort Lowell Rd. However, on July 31, 2015 Sacred Heart Catholic Church (the facility owner), informed us that the school facility had failed the Fire Marshall inspection.

We were very surprised by this news because the Church had assured us that the Fire Marshall Inspection would be a mere formality. The reason being that the church property as a whole had passed this type of inspection three to four years earlier when a new fire alarm system was installed on the property.

Given this setback, we could not open the school on August 6, 2015 and there was no guarantee that the Church will have the facility ready for school by the new opening date of August 13, 2015. Consequently, we decided to open the school at 40 W. Fort Lowell Rd; a facility occupied by Tucson Collegiate Prep. Meanwhile, with this second postponing of the school opening, we lost two excellent teachers and started school operations with only 16 of the 42 students that had originally enrolled at Seneca Preparatory Academy (SPA).

We are seeking an Instructional Day Amendment because with the new school calendar, SPA will provide only 178 days of instruction this year, versus 182 days as stated in the original application, and less than the 180 days required by state law. However, as shown in the table underneath, all students at Seneca Preparatory Academy will receive 1,192 hours of instruction in 2015-16.

Consequently, even with 178 days of instruction, Seneca Prep will still comply with state status because ARS 15-901(A) (2) (a) (i) and ARS 15-901(A) (2) (a) (b) (i) provide the following guidance for the minimum hours of instruction per year required for full-time students: a) Kindergarten: 356 hrs. b) Grades 1, 2 & 3: 712 hrs. c) Grades 4, 5 & 6: 890 hrs.
