

**Alternative Calendar** – Discussion and approval of a four (4) day week High School Calendar for fiscal year 2009-10 and beyond. Skyline School's High Schools would move from the traditional five (5) day a week school calendar to an alternative four (4) day a week calendar.

- **Skyline Technical High School**

- The school week would be Monday thru Thursday
- School day would be from 9:15 AM to 4:05 PM
- Students would be able to earn eight (8) credits per year
- Friday would be required as a make-up day for student absences which occurred during Monday thru Thursday of the current week with teachers who will maintain the regular daily class schedule.
- Friday would also be available for AIMS tutoring, credit recovery, in-school suspension, and teacher in-service/training.

- **Skyline West Prep School**

- The school week would be Monday thru Thursday
- School day would be from 7:55AM to 3:05 PM
- Students would be able to earn eight (8) credits per year
- Friday would be required as a make-up day for student absences which occurred during Monday thru Thursday of the current week with teachers who will maintain the regular daily class schedule.
- Friday would also be available for AIMS tutoring, credit recovery, in-school suspension, and teacher in-service/training
