AGENDA ITEM: Transfer Application – Ventana Academic Charter School 2009-2010 Transfer Application Summary Report

Ventana Academic School filed a transfer application to transfer their current charter contract which operates Ventana Academy from the State Board of Education to sponsorship with the Arizona State Board for Charter Schools. The transfer includes a change in the corporate name to Ventana Academic Charter School and a change in the mission as reflected in this report. Ventana Academic School is a non-profit corporation that was organized on February 19, 1992. Ventana Academic School was chartered with the State Board of Education with a contract effective date of September 5, 1995.

According to the Arizona Department of Education's ADMS Report 45-1, Ventana Academic School had a reported Average Daily Membership (ADM) of 64.97 students in 2007. The ADM rose to 93.02 students in 2008 and has grown to 112.43 students in 2009.

Curricular Emphasis:

To support the school's emphasis on science and technology, the school regularly schedules learning outside the classroom through their garden club and field trips to such places as veterinarian clinics, animal rescue organizations, The Heard Museum and The Challenger Space Center. Students are offered a wide variety of software options to advance them within today's educational environment. Software includes math and reading skills instruction and support.

Governance Structure:

The school has a single governing entity, namely the Ventana Academic Governing Board. The major responsibilities include oversight of all financial matters, establishment of school policy and the employment and removal of the principal and all paid employees and contractors/vendors of the Academy. The application state that the Board shall at all times, recognize that in addition to establishing school policies, its duty is to support the principal in the overall administration of the school.

The mission of the charter is as follows:

Ventana Academy, a K-8 school of choice, provides a superior quality educational experience that instills students with a love of learning and imbues them with the essential academic skills and knowledge relevant to both today and tomorrow. Ventana uses rigorous, innovative, data-driven instruction with a focus on science and technology in mall class sizes that nurture their intellect and spirit while surrounding them in a secure, cooperative environment rich with the contributions from our parents and extended community.
