# 6. Westwind Preparatory Academy at Anthem

Due to the fact that WAA had not met the enrollment goal and feedback from parents and students indicated a desire to have more electives and extracurricular activities, the board determined that both the WPA site and the WAA site should be consolidated at the Northern Avenue (WPA) campus.
