AGENDA ITEM EXECUTIVE SUMMARY: New School with Enrollment Cap Amendment Request

Request

Math and Science Success Academy, Inc. ("Charter Holder") submitted an expansion amendment request to add a new school to the existing charter contract in FY 2021, and to increase the enrollment cap from 2550 to 4263, beginning in FY 2020. This expansion request accounts for three years of projected expansion.

The Charter Holder has requested to add a fourth school to the charter contract in order to continue to deliver "high performance in low-income and underperforming areas" and meet "the high demand exhibited" for its programs. Academy of Math and Science Heroes Park plans to reach its enrollment target using online, mailing, and in-person marketing campaigns. The staffing plan includes utilizing internal candidates as administration at the new campus and the need to hire 78 total staff members in the first year. The narrative states that staff recruitment will be done through employment websites, university job boards, social media, and career fairs. At the proposed school, the Charter Holder intends to offer a 200-day calendar and provide more instructional time than is offered at other nearby schools. Additionally, the school plans to offer STEM curriculum, foreign languages, and extracurricular programs, that are not offered at other nearby schools.

Past enrollment trends indicate the charter will exceed its enrollment cap within the next three years.	ADM in FY 2017 was 440.382, in FY 2018 was 604.957, and in FY 2019 was 660.671 (as of April 22, 2019). Based on this trend the Charter Holder would exceed its current enrollment cap of 700 in FY 2020. It is important to note that the Charter Holder was approved at the May 2018 Board meeting to operate two news schools starting in FY 2020 and have its enrollment cap increased to 2550. However, this cap increase is not effective until FY 2020 when the two new schools are opened.
ADM is within 85% of current enrollment cap.	According to ADE School Finance, the Charter Holder currently has an ADM of 660.671. The charter holder is currently operating at 94% of its current enrollment cap of 700.








Enrollment and Demographic Data
