The meeting convened at 3:00 pm at the 4710 East Baseline Road in Mesa, AZ. Present were Ryan Christensen, Jerad Hunsaker, Michael Scott and Charlotte Day. Chairman Ryan Christensen conducted the meeting.

1. Minutes of the previous regular meeting had been previously emailed to the members. Corrections had been made as requested by Ryan. Michael moved and Ryan seconded to accept the minutes. Voting was unanimous in the affirmative.
2. Ryan presented the financial report for February 1, 2013 to February 28, 2013.
3. The board discussed the Marketing Plan of the Corporation. There was a lengthy discussion of the matter. Because of the change in management it was recommended that the school change its name and rebranded itself. Ryan moved and Jerad seconded that the school change its legal name to Hillcrest Academy, Inc. further it change the school name of Destiny Community School to Hillcrest Academy effective July 1, 2013 to align with the fiscal year. By unanimous vote, the following resolutions were passed:

RESOLVED: That the school change its legal name to Hillcrest Academy, Inc. effective immediately and that it change the school name of Destiny Community School to Hillcrest Academy effective July 1, 2013.
