### Board Meeting Summary & Updates

#### November Board Meeting

The ASBCS November Board Meeting was held Monday, November 22, 2021. The Board was joined by Associate Superintendent Kate Wright, sitting in for Superintendent Kathy Hoffman who recently welcomed her first child into the world- congratulations Superintendent Hoffman!

### Important Updates: ESSER Data Reporting

From the Arizona Department of Education

#### **Pause on ESSER Data Reporting Collection**

The US Department of Education has just released new guidance to states that serves to update previously released requirements for ESSER (I, II and III) grant data reporting by states and LEAs. This update includes changes to current data elements, the removal of some elements and sections, and the inclusion of new items. Upon review, these changes include, for example, the removal of the requirements for LEAs to report obligations of funds, and data regarding allocations to high poverty schools for Maintenance of Equity (MOEquity).

Given these new development from USED, **ADE is pausing the ESSER Data Reporting process through the GME ESSER Reporting Supplement, and is suspending the previously announced deadline for submitting these data of December 17th.** ADE will provide an update regarding next steps in the coming weeks.

#### **Extension of ESSER III Deadline**

**The deadline for submitting the ESSER III grant applications has been extended to February 1, 2022.** This is a hard deadline with the expectation by USED that all applications will be submitted no later than February 1, 2022.

## Suicide Prevention Training for Schools

From the Arizona Healthcare Cost Containment System

In 2019, the Arizona State legislature passed Senate Bill 1468 mandating all public school staff be trained in an evidence-based, best practice suicide prevention training at least once every three years.

Known as the Mitch Warnock Act, named after a Tempe teenager who died by suicide, the statute states that AHCCCS will select evidence-based, best practice suicide prevention training materials.

The law went into effect at the beginning of the 2020-2021 school year and mandates that all school staff who interact with students in grades 6 through 12 must receive suicide prevention training at least once every three years.

The Arizona Health Care Cost Containment System (AHCCCS), in coordination with the Arizona Department of Education (ADE), have selected the following school suicide prevention training options. School administrators can choose from among these materials as they work toward meeting the statute's requirements.

- Question, Persuade, Refer (QPR).
- Applied Suicide Intervention Skills Training (ASIST).
- At-Risk for High School Educators (available online, and in Spanish).
- Youth Mental Health First Aid.
- Suicide Alertness for Everyone (safeTALK).
- ACT on FACTS (available online).
- More than Sad – Suicide Prevention Education for Teachers and other School Personnel.
- Be a Link! Suicide Prevention Gatekeeper Training.

The methodology used to select these materials include the review of The Substance Abuse and Mental Health Services Administration's (SAMHSA) Suicide Prevention Toolkit for High Schools, review of the Suicide Prevention Resource Center for additional gateway trainings, and review of articles addressing cultural considerations, particularly for tribal nations, in suicide prevention. This work was conducted by a third-party contractor.

## FY22 American Rescue Plan Homeless II Application

From the Arizona Department of Education

Dear School Leaders,

This is a formal notification of your Local Education Agency's (LEA's) ability to apply for the ARP Homeless II grant for the fiscal year ending September 30, 2022.

The American Rescue Plan (ARP) Act of 2021 included additional monies within the Elementary and Secondary School Emergency Relief (ESSER) Fund to support the specific and urgent needs of homeless children and youth due to the impact of the Coronavirus-19 (COVID-19). To this end, the U.S. Department of Education (USDE) awarded each State Educational Agency (SEA) funds proportional to those received under Part A of Title I of the Elementary and Secondary Education Act (ESEA) of 1965 in the most recent fiscal year.

Arizona received a total allocation of \$16,914,124 for ARP Homeless Children and Youth (ARP-HYC) funds, with \$9,520,398.00 set aside for grant allocation for the ARP Homeless II. On the [ADE Homeless Education Program Funding page](#), the [ARP Homeless II Allocations per LEA](#), USDE guidance, and new allowable use of funds are provided. The allocations are based on a formula provided by the U.S. Department of Education. The formula utilized the amount of Title 1, Part A allocated in FY20 and the greater number of homeless students reported for the 2018-2019 or 2019-2020 school year for each LEA. LEAs with an allocation threshold of \$5,000 or less will be required to join a consortium.

One of the purposes of the ARP-HCY program is to provide wrap-around services considering the challenges of COVID-19. Therefore, ARP-HCY funds may be used for pre-award costs dating back to March 13, 2020, when the national emergency was declared. The ARP Homeless II Project is set to end on September 30th, 2023.

However, carryover will be allowed until September 30th, 2024 with a final drawdown date of January 31st, 2025. The ARP Homeless II application will be released on Friday, November 12th. ## Update to Arizona Residency Guidelines

During the 2021 Legislative Session, lawmakers passed Senate Bill 1420 to require this state or any political subdivision of this state to accept a consular identification card that is issued by a foreign government as a valid form of identification if the foreign government uses biometric identity verification techniques in issuing the consular ID. This bill also states that "biometric identity verification techniques" includes fingerprint identification and retina scans.

Because school districts and charter schools are considered political subdivisions of this state, the Arizona Department of Education has updated the [Arizona Residency Guidelines](#) to include consular identification cards as an accepted form of verifiable documentation for enrollment. In the revised guidelines, you will find consular identification cards listed as an option for verifiable documentation. These new changes are effective as of September 29, 2021.

## ESEA Consolidated Grant Application

ESEA (Title I) Consolidated grant has an application deadline coming up for Established Charter Schools. Any charter school that is operating in FY22 can apply for FY23 funding using October 1, 2021 enrollment and poverty data. The due date for the application is December 1, 2021.

The next deadline will be April 1, for any New or Expanding charter schools who wish to use projected FY23 enrollment and poverty data for FY23 funding and also any Established charters who missed the December 1 deadline.

**Responsibilities for Notice and Information**  
**§76.788 What are a charter school LEA's responsibilities under this subpart?**  
(2)(ii) An SEA is not required to provide funds to a charter school LEA until the charter school LEA provides the SEA with the required actual enrollment and eligibility data.

(c) **Compliance.** Except as provided in §76.76.791(a), or the authorizing statute or implementing regulations for the applicable covered program, a charter school LEA must establish its eligibility and comply with all applicable program requirements on the same basis as other LEAs.

## **[Apply for ADE ESSER Project Funds](#)**

This email is a reminder that eligible organizations, including LEAs, can now apply for ESSER III set aside funds available as part of the Arizona Department of Education's (ADE) ESSER Project Funds. Set aside funds refer to dollars available at the discretion of ADE for statewide strategic projects and investments.

The application for ESSER III set aside funds is due December 10, 2021. All eligible organizations are encouraged to apply. Find more information, including guidance documents, on the [ADE ESSER III set aside application webpage](#). You can find application information on the [Arizona Procurement Portal](#). Select "Open Solicitations" from the welcome page and enter the RFGA number BPM004016 as a keyword.

While LEAs can apply for ADE ESSER Project Funds via the ESSER III set aside [application](#), ADE encourages all LEAs to first view and apply for the ESSER funds directly available to them via three federal packages: CARES ([ESSER I](#)), CRRSA ([ESSER II](#)) and ARP ([ESSER III](#)).

Notably, eligible LEAs should apply for their allocated ESSER II funds as soon as possible and for ESSER III allocations ahead of the February 1, 2022 deadline.

**AZ Public Charter Schools  
Drinking Water Testing Opportunity**

The Arizona Department of Health Services (ADHS) is currently offering water testing services to public charter schools for lead. This effort is made possible by funding from the U.S. Environmental Protection Agency (EPA). This funding opportunity is known as the WIIN Grant: [Lead Testing in School and Child Care Program Drinking Water](#).

This project is a continuation of previous water testing work completed by ADHS in [licensed child care facilities](#), and the Arizona Department of Environmental Quality (ADEQ) in [public schools](#). While drinking water has not historically been found as a cause of lead poisoning in Arizona, ADHS intends to take a proactive approach to protect Arizona's children.

The primary goals of this project are to:

- offer services to test drinking water fixtures of public charter schools serving younger children, especially those under 6 years of age, first
- offer services to test drinking water fixtures of all public charter schools in Arizona by the end of the project period
- provide education about lead exposure and the importance of testing to all public charter schools

Coconino, Mohave, and Yuma County staff agreed to participate in the program sampling activities and are responsible for coordinating testing in public charter schools within their respective jurisdictions. ADHS is working with Dominion Environmental Consultants, Inc. to coordinate testing in the remaining counties. Schools in the remaining counties will be contacted by [Dominion Environmental Consultants, Inc.](#) to coordinate water sample collection starting in November 2021.

Collection of water samples from your facility is voluntary. However we hope that you will take this opportunity to join the fight in eliminating sources of lead in Arizona and protect Arizona's children. If a water sample comes back elevated, ADHS will work with your school to design an appropriate response and provide guidance on targeted remediation.

25 schools have already had their water tested. For test results and additional information please visit our webpage at [www.azdhs.gov/lead/WIIN](http://www.azdhs.gov/lead/WIIN). Results will only be posted once the remediation option has been implemented.
