Excerpt:

Reimbursement might include driving for professional developments or going to conferences as requested. Conference fees and professional development fees will be paid for by Skyline Gila River, LLC.

Rudy Dolfo made a motion to accept the By-Law policy as written. Zyzick Owens seconded the motion and all approved unanimously.
